The Yahnundasis Golf Club is pleased to offer the following promotional package for prospective new members of our Golf Club.The Club offers an array of activities for individuals and families interested in an exciting golf and country club experience. Whether it's golf, swimming in our new pool, tennis, pickleball, or many social events, dining al fresco or simply enjoying refreshments around our fire pit overlooking the 9th and 18th hole greens, the Yahnundasis is a year-round destination offering our members and their families an exceptional member experience. A new member may join and enjoy membership privileges within the membership category selected on the membership application.

THE GOLF MEMBERSHIP PROMOTIONAL PLAN

A golf membership provides the member with privileges to use all amenities that the Club offers. Prospective new members are offered a one-time promotional payment discount. Payment as listed below for each membership category is due at the time of application, plus Oneida County sales tax of 8.75%. There will be no further dues payments required until May 2026. Monthly statements are sent out at the first of each month to include any food, beverage, golf, or other club usage-related charges. Payments may be made by ACH, or credit card (a 3% surcharge will be applied to all payments made by credit card.)

RESTAURANT MINIMUM AND SERVICE CHARGE

Our Restaurant minimum year runs June 1st through May 31 of the next calendar year. There is an annual restaurant minimum purchase requirement of \$750.00, which will be pro-rated for the first year. The Club automatically adds a 20% service charge to each food and beverage purchase. Unused restaurant minimums will be billed to the Membership account.

Oneida County Sales tax of 8.75% will be added.

THE SOCIAL MEMBERSHIP PROMOTIONAL PLAN

A social membership provides the member with privileges to use all amenities that the Club offers except for golf. Social members may use the golf course up to four times a year provided they pay for their usage at the prevailing rate that applies to guests. They may not use the golf practice range. Prospective new social members are offered a one-time promotional payment discount. Payment as listed below for each membership category is due at the time of application, plus Oneida County sales tax of 8.75%. There will be no further dues payments required until May 2026. Monthly statements are sent out at the first of each month to include any food, beverage, or other club usage-related charges. Payments may be made by ACH, or credit card (a 3% surcharge will be applied to all payments made by credit card.)

RESTAURANT MINIMUM AND SERVICE CHARGE

Our Restaurant minimum year runs June 1st through May 31 of the next calendar year. There is an annual restaurant minimum purchase requirement of \$750.00, which will be pro-rated for the first year. The Club automatically adds a 20% service charge to each food and beverage purchase. Unused restaurant minimums will be billed to the Membership account.

Oneida County Sales tax of 8.75% will be added.

MEMBERSHIP CLASS DESCRIPTIONS

(a) A Golf Membership class may be either "Household" or "Single". In the case of a Golf Household Membership, the individual of the household who applies for membership in the Club and is approved by the Board of Governors is the only Club Member in that household, even though the Members of their Household, are entitled to the Club's privileges. For a Household Golf Membership, privileges are extended to a Member's spouse or significant other, in addition to children under the age of 26. In the case of a Single Golf Membership, the individual of the household who applies for membership in the Club and is approved by the Board of Governors is the only Club Member in that household entitled to golf privileges with the following exception. To promote the game of golf, a parent who is a Single Golf Member is entitled to have their children who are under 14 years of age golf with them. Once their children become 14 years of age, the Member must transition their membership to a Household Golf Membership to retain this privilege.

(b) "Associate Colf Member" is a membership class for those under thirty six years of age. The Associate Golf Membership may be either "Household" or "Single". In the case of a Household Associate Golf Membership, the individual of the household who applies for membership in the Club, and is approved by the Board of Governors, is the only Club Member in that household.For a Household Associate Golf Membership, privileges are extended to a Member's spouse or significant other, in addition to children under the age of 26. In the case of a Single Associate Golf Membership, the individual of the household who applies for membership in the Club and is approved by the Board of Governors is the only Club Member in that household entitled to golf privileges with the following exception. To promote the game of golf, a parent who is a Single Associate Golf Member is entitled to have their children who are under 14 years of age golf with them. Once their children become 14 years of age, the Member must transition their membership to a Household Associate Golf Membership to retain this privilege.

(c) "Social Members" shall be persons elected to membership who wish to enjoy all the social aspects that the Club has to offer including the Clubhouse, tennis and pickleball courts and the pool. They do not have golfing privileges. Social members may use the golf course up to four times a year provided they pay for their usage at the prevailing rate that applies to guests. They may not use the golf practice range.

(d) "Out of Town Members" Is a membership class for only Single Golf membership to any individual that lives greater than a 40 mile distance from the Yahnundasis Golf Club without any local residential accommodations. For an "out of town" golf membership the individual will be entitled to all of the Club's privileges and will be required to pay their annual dues (\$2,000) via ACH or Credit Card at the time of joining. A cap of 25 out of town members will be allowed.

MEMBERSHIP CLASS DESCRIPTIONS

(e) "Corporate Members" A corporation, partnership or other business entity may nominate individuals as corporate privilege holders. These individuals shall have the privileges of Social Membership. Within a fiscal year, substitutions of an individual may be permitted only with Board approval upon conditions set by the Board of Governors.

Definition of "Significant Other" Privileges may also be extended to an individual nominated by a Member to be a "significant other" of the member, conditioned upon the following qualifications. The Member and "significant other" must both be unmarried. The Member may only designate one "significant other" per fiscal year. All purchases made and charges incurred by the "significant other" shall be the sole responsibility of the member. In the event that the "significant other" will have other privileges to which extra fees apply, the member's account will be charged with those fees. Unless the children of the "significant other" cohabit with the member, neither they nor relatives of the "significant other" shall have Club privileges but may be treated as "guests" of the Member. In the case of Single Golf and Single Associate Memberships, golf privileges are extended only to the Member and their children under the age of 14, though all other household members may use the golf facilities as "guests" of the Member subject to appropriate restrictions and fees.
